Five Pillars of PQMD

1. DONATION GUIDELINES

The “PQMD Guidelines for Quality Medical Product Donations” are a set of guidelines for health supply and service donation across the globe.

- Foundation of PQMD
- Influence and assure high standards of donations
- Updated annually and approved by board

2. HUMANITARIAN ASSISTANCE

Members donate and deliver hundreds of millions of dollars’ worth of medical products and services each year for humanitarian assistance in the U.S. and around the world.

- Coordination between and among members
- Assistance to most vulnerable communities

3. DISASTER RESPONSE

When a catastrophe strikes, members are among the first to respond with health-saving contributions, with short-term emergency aid to communities.

- Initiate process of rebuilding healthcare infrastructures
- Address the complex logistics of any situation efficiently and effectively
- Ensure health needs of disaster-affected populations are quickly met

4. HEALTH SYSTEMS STRENGTHENING

Members are recognized as leaders in their industry or field of practice, making them optimally positioned to:

- Advance service delivery, to
- disseminate health workforce information
- develop, donate, and deliver medical products and technology to build resilience and empower communities

5. KNOWLEDGE AND INNOVATION


KEY ROLE IN COORDINATING DISASTER MANAGEMENT RESPONSE
