Note from Elizabeth (EJ) Ashbourne, PQMD Executive Director

As we conclude this very challenging but successful year, I would like to offer just a couple of highlights of our work in 2023. In the past 12 months, PQMD welcomed 10 new members, the most ever to join in one year. In addition to hearing from global experts and local practitioners in our Pillar Talks and Coffee Chats, we were able to hold our first post-COVID, in person, Global Health Policy Forum in Paris, France, hosted by Sanofi, with high-level participants from all over the world. In October, we met again to discuss climate change, supply

chain, health systems strengthening and sustainability at our members-only **2023 Education Forum** in Santa Barbara, California, hosted by Direct Relief. We continued to expand our Guidelines portfolio with the development of our **Rare Disease Guidelines** as part of the Global Alliance for Rare Diseases (GARDaccesss) initiative. We have started new and budding partnerships with several universities, coalitions, organizations and institutions that will provide opportunities for PQMD and its members to contribute to emerging global trends in universal access to quality healthcare. And as always, we have highlighted and supported the incredible work that our members have engaged in on the front lines of humanitarian crises and disaster response including in Ukraine, Turkey & Syria, Sudan, Morocco & Libya, Hawaii, Israel, and Gaza, and many other places around the globe. We look forward to sharing our comprehensive Year in Review report with you next month!

I am also very excited to announce that we have just released the 2023 PQMD's
Guidelines for Quality Medical Donations. The updated guidelines include newly approved revisions including aspirational language around carbon emissions, and definitions for off label use, temperature excursions, customs clearance, emergency use authorization procedures, among others. Also now available, are the event reports from our recent **October Education Forum** including highlights, summaries from our breakout sessions, links to photos, and other valuable insights. PQMD Board of Directors Approves Donation Guidelines Updates

This 2023 edition of the PQMD Guidelines, approved by the members of the PQMD Board of Directors on December 6, 2023, reflects the base of knowledge, experience and expectations of the membership for how medical product donations should be carried out. Some of the updates include:

- Detailed additions to the logistics section around shipping preparation and processing as well as managing risks.
- Aspirational language around carbon emissions was added with the expectation of future build out as climate considerations become further incorporated into donations.
- Definitions were added around off label use, temperature excursions, customs clearance, and emergency use authorization among others.

The course will be presented in seven modules over seven weekly classes scheduled Wednesdays from 12:00-2:00pm (EST).

PQMD has condensed key elements of a Master's in Public Health curriculum to create a comprehensive Executive Survey Course on global health, for professionals or students working in the space but lacking relevant formal education.

The course compresses much of the MPH curriculum with an emphasis on global concerns; participants gain an improved understanding of health disparities around the world and how they're measured, health systems in low and lower-middle income countries, the global frameworks and key players providing sustained humanitarian assistance for global health development, and the dynamics and coordination of international disaster response.

The course is structured in 7 modules, and delivered through weekly 120-minute online sessions. Modules are delivered by topic-specific expert guest lecturers, including the course coordinator, a seasoned global health professional with substantial experience in the subject matter and adult education.
