**PQMD Members Mark One-Year Anniversary of Ukraine Invasion** 

February 24th marks one year since Russia invaded Ukraine. The World Health Organization (WHO) is concerned about the worsening health situation in the Ukraine. This includes untreated chronic diseases, mental health and access to medicines. The situation is worsened by the continued attacks on health care by Russia. The WHO has reported more than 800 attacks on health care.

**PQMD Members Respond to Earthquake in Turkey and Syria** 

On February 6, 2023, a 7.8 earthquake struck southern and central Turkey and northern and western Syria. As of February 26, 2023, more than 51,100 deaths were confirmed: more than 44,300 in Turkey, and more than 6,700 in Syria. Collectively, the earthquakes are estimated to have caused \$84.1 billion in damages.

PQMD members have been responding to this crisis. The Disaster and Humanitarian Response Committee held two coordinating calls in February to discuss how each member is responding and opportunities for collaboration. ## Essential Medicines Arrive in Syria, Post-Earthquake

On Tuesday, February 14th, 14 pallets of medical aid from Direct Relief arrived in Syria to support the medical efforts of the Syrian American Medical Society, which operates hospitals in northwestern Syria that have been inundated with patients following a deadly earthquake in the region last week.

The 6,800-pound shipment was trucked from Adana, Turkey, and transported into Syria, and contains more than 64,000 defined daily doses of requested antibiotics for infection treatment and other essential medicines.

Tuesday's shipments are the latest to arrive in Syria, and Direct Relief currently has 22.5 tons of emergency medicines and supplies valued at \$4.5M that is ready for shipment, en route or has arrived in the region. In addition to the Syrian American Medical Society, Direct Relief is also shipping medical support to the Independent Doctors' Association and Syria Relief and Development, all of which support medical efforts in the country.

In the week since the initial quake, Direct Relief has disbursed \$1.52 million in immediate emergency grant funding to enable and sustain the emergency response operations of seven local healthcare and search and rescue groups working across Turkey and northwestern Syria.

The death toll from the 7.8-magnitude earthquake that struck Turkey and Syria in the early hours on February 6 has now exceeded 40,000, and the head of the United Nations relief effort on the ground, Martin Griffiths, stated publicly that this total will likely double or more.

More than 24,000 buildings have been damaged or destroyed in the affected areas, and 8,400 of these structures have



### Hundreds Living with Hemophilia in Lebanon Just Got A Boost

Hemophiliacs in Lebanon confront many challenges to living an ordinary life. A 2019 study concluded that the majority of Lebanese patients with hemophilia have "difficulties in social integration, have severe physical limitations and psychological impairments."

In Lebanon, hemophiliacs have confronted new challenges to managing their conditions in recent years. The medical and pharmaceutical sectors have been badly shaken by the nation's economic collapse. The crisis has affected access to essential medications for patients with chronic conditions, affecting all ages and communities.

The 2020 port explosion that shook the capital was yet another challenge. The blast damaged Karantina Hospital, Beirut's main public hospital and medical distribution point.

In answer to this need, Anera has received a medication shipment from Direct Relief. The shipment contained 2,100 vials of antihemophilic factor VIII. Antihemophilic factor is a glycoprotein used in treatment for patients with hemophilia to help control bleeding. An estimated 350 patients in Lebanon will receive this donation, which will cover their needs for six months. The patients will collect their medication from the Karantina Ministry of Public Health warehouse.

conapsed. In northwestern Syria 7,400 buildings have been damaged or destroyed, including 57 hospitals and primary health facilities damaged, and 1,700 of that total have collapsed.

Major concerns include emergency medical and surgical supplies for hospitals, disease outbreaks due to numbers of displaced people without shelter and access to proper water, sanitation and hygiene facilities, and winterization needs, including for medical shelters.

After 12 years of conflict and an ongoing cholera outbreak, 4.1 million Syrians in the northwest already relied on some level of humanitarian assistance before the earthquake, with recent events overwhelming the capacity of local health facilities.

The UN estimated that almost 9 million people have been affected by the earthquake across Syria, and the Syrian American Medical Society has reported that many people are now exposed to the winter weather, lacking adequate shelter and that they are preparing for surges in communicable diseases and potentially cold-induced injuries.
