#### PQMD Launches New Series of Local 'PQMD Member Meet Up': Join Us in Boston on March 12th!



#### Anera and Direct Relief Partner to Bridge Health Gaps in Lebanon

Amid Lebanon's economic challenges, where the cost of medical treatments has become an obstacle for many, a medical donation arrived earlier this month that has brought a glimmer of hope to individuals battling autoimmune diseases. A partnership between Anera and Direct Relief has resulted in a new shipment of critical supplies, featuring a medication known as adalimumab. This medication specifically targets autoimmune diseases such as rheumatoid arthritis, Paget's disease, and Crohn's disease.

Mercy Ships strives to make safe surgical care accessible for as many as possible on board our fleet of floating hospitals, providing more than 114,000 life-changing or lifesaving surgical procedures since 1978. However, the sad reality is that not every single patient Mercy Ships meets can benefit from surgery. This is where the palliative care team comes in, serving to bring hope and healing through compassionate care and companionship to February 24th marked two years since the beginning of the war in Ukraine. # Ukraine Relief: Two Years into the War, Response Continues

February 24, 2024, marks two years since Russia's full-scale invasion of Ukraine. Believed to have so far claimed several hundred thousand lives, including those of tens of thousands of civilians, this violent and destructive war shows no signs of ending.

In response, Direct Relief provided more than 1,900 tons of medical aid over the past two years, and more than \$42 million in financial assistance has gone to health providers offering services to impacted patients.

#### Americares Delivers Over 500 Tons of Medicine and Supplies to Ukraine

Since the war in Ukraine catapulted the region into a major humanitarian crisis two years ago, Americares has provided more than 500 tons of medicines and medical supplies and \$5.3 million in emergency funding to protect the health of the most vulnerable survivors.
